



TERMS AND CONDITIONS FOR BUY ONE GET ONE FREE SHUTTLE TRANSFER PROMOTION

- 1. **Terms and Conditions of Entry** Participants agree to be bound by these terms and conditions by participating in and accepting the benefit of this Promotion.
- **2. Promotion:** Free return travel from Brisbane West Wellcamp Airport to Toowoomba when purchasing a shuttle transfer from Toowoomba to Brisbane West Wellcamp Airport with Peters Coaches, Toowoomba.
- 3. **Promoter** The Promoter is Brisbane West Wellcamp Airport and Peters Coaches.
- 4. **Eligibility Requirements** Participants are eligible to participate in the Promotion only if they hold a current pension card which must be presented to the driver of the shuttle service on pick up.
- 5. **Promotion Period** the Promotion Period will run from 1 June 2017 to 31 August 2017 and return trips are only available under this Promotion for return travel during the Promotion Period.
- 6. **General Terms and Conditions** The general terms and conditions for the Promotion are:
 - a. A Peters Coaches shuttle transfer from Toowoomba and some surrounding suburbs to Brisbane West Wellcamp Airport must be purchased or booked directly through Peters Coaches;
 - b. Any booking through Peters Coaches must be booked and paid for in full, in advance.
 - c. The participant must have a valid airline ticket departing Brisbane West Wellcamp Airport during the Promotion Period
 - d. The benefit of the promotion is limited to a maximum transfer value of \$55.00 and the benefit must be equal to the value of the paid transfer.
 - e. Time and pick up locations will be at the sole discretion of Peters Coaches
 - f. Maximum one free return shuttle travel per person during the Promotion Period
 - g. Limited seats per shuttle are available so the free return transfers will be given on a first in basis
 - h. Participants accepting the benefit of the Promotion consent to the Promoters using personal details of purposes associated with the Promotion.
 - i. A participant may not assign the benefit (being the return shuttle transfer) to any other party.
